

# Cumberland Community Foundation Nonprofit Leadership Award

## 2008 Nomination Form Nominations Due: **September 22, 2008**

The Cumberland Community Foundation awards this prestigious Nonprofit Leadership Award to recognize, encourage, and reward extraordinary nonprofit leadership by a board member. The winner will be recognized at the Foundation's Nonprofit Awareness Month event in November 2008. A grant in the amount of \$1,000 will be awarded to be used for staff training and board development.

How many awards will be given?

It is a competitive nomination and one winner will be selected.

Who may do the nominating?

Nonprofits in Cumberland County that have an annual financial audit are eligible to nominate a current board member or recent alumnus.

When are nominations due?

Nominations must be received (not postmarked) no later than Monday, September 22, 2008 at 5:00 p.m.

Can nominating organizations apply for other grants from the Foundation?

Yes, nominating a candidate does not preclude the group from applying for any other grants in the same year or grant cycle.

  - c. Describe ways that the Nominee has reenergized the board and the organization to fulfill its mission, using examples such as of improved attendance at meetings, increased board giving, re-organization of committee work, and/or board member testimonials.
  - d. Describe ways that the Nominee has led the development of innovative collaborations within the community. Name those partnerships and the Nominee's role in developing them.

The nomination must be signed by the Nominator and Board Chairman or President and received no late than 5:00 p.m. on September 22.
